Deciding upon the application of the Company for the collection, primary processing and trade of secondary raw materials "MITECO - KNEŽEVAC" Limited liability company, Belgrade (Rakovica), Oslobođenja 39, for establishing compliance with requirements for commencing and conducting public transport, as per art. 42, par. 1 of the Law on Road Transport ("Official Gazette of RS" nos. 46/95, 66/01, 61/05, 91/05, 62/06 and 31/11), art. 6 of the Law on Ministries ("Official Gazette of the RS" nos. 44/14, 14/15 and 54/15), and art. 192, par. 1 of the Law on General Administrative Proceedings ("Official Gazette of the FRY", nos. 33/97 and 31/01 and "Official Gazette of the RS" no. 30/10), pursuant to the decision of authorization number 031-01-00031/2/2015-02 dated February 27, 2015 we are hereby enacting the following

DECISION

It is hereby established that the Company for the collection, primary processing and trade of secondary raw materials "MITECO - KNEŽEVAC" Limited liability company, Belgrade (Rakovica), Oslobođenja 39, complies with requirements for commencing and conducting public transport of goods, as per articles 3, 5, 6 and 9 of the Law on Road Transport, with vehicles with the following registration plates:

Rationale

Based on the application submitted by the Company for the collection, primary processing and trade of secondary raw materials "MITECO - KNEŽEVAC" Limited liability company, Belgrade (Rakovica), Oslobođenja 39, and the review of submitted documentation on compliance with requirements for commencing and conducting public transport of goods as per articles 3, 5, 6 and 9 of the Law on Road Transport, it has been established that the applicant complies with the said requirements.
